Opening Letter

As we look back across fiscal year 2019, Team BAC has much to be proud of thanks to our community supporters, partners, teammates and friends.

In the coming pages, you will celebrate with us the outstanding financial results we realized; the vast impact our work within the federal AbilityOne program had on our customers and employees, and success after success of the hundreds of people we serve who met and surpassed personal goals and gained competitive employment in area businesses or on our contracts.

At its core, our work is simple: link people with differing abilities to jobs and programs that fit their unique skill sets and needs to assist them in achieving as much independence and growth as possible. In practice however, we know this can be far from easy.

This year, we've continued to make strides toward our five-year strategic goals (found on page 18) which aim to aggressively grow access to employment and empowerment opportunities. We are also clear of the very real challenges before us as we close in on these targets.

Threats to our traditional funding sources and current contract and service model, a tight labor market, rising wages and the cost of living all add significant pressure to our leadership team to find creative solutions and ways forward for those we serve.

We've undertaken steps to enhance our processes including a significant re-organization effort and improvements to internal infrastructure. The new organizational structure draws together our former Employment Services and Habilitation programs to improve access to training and employment outcomes for our participants. Infrastructure investments such as facilities updates and human resources software will improve our ability to on-board and support our participants and employees.

We also know that our team, from entry-level and beyond, brings a passion for and commitment to our mission every single day. This, above all else, will drive us toward success.

We are excited about our potential to continue to expand our impact. We welcome your continued investment in BAC and thank you for your support as we head into a new year of helping people with disabilities achieve success.

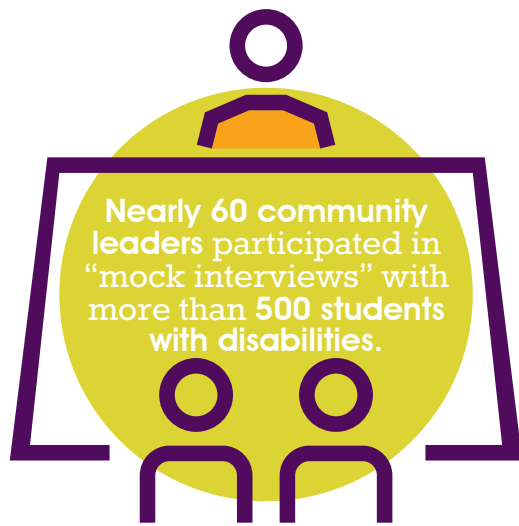

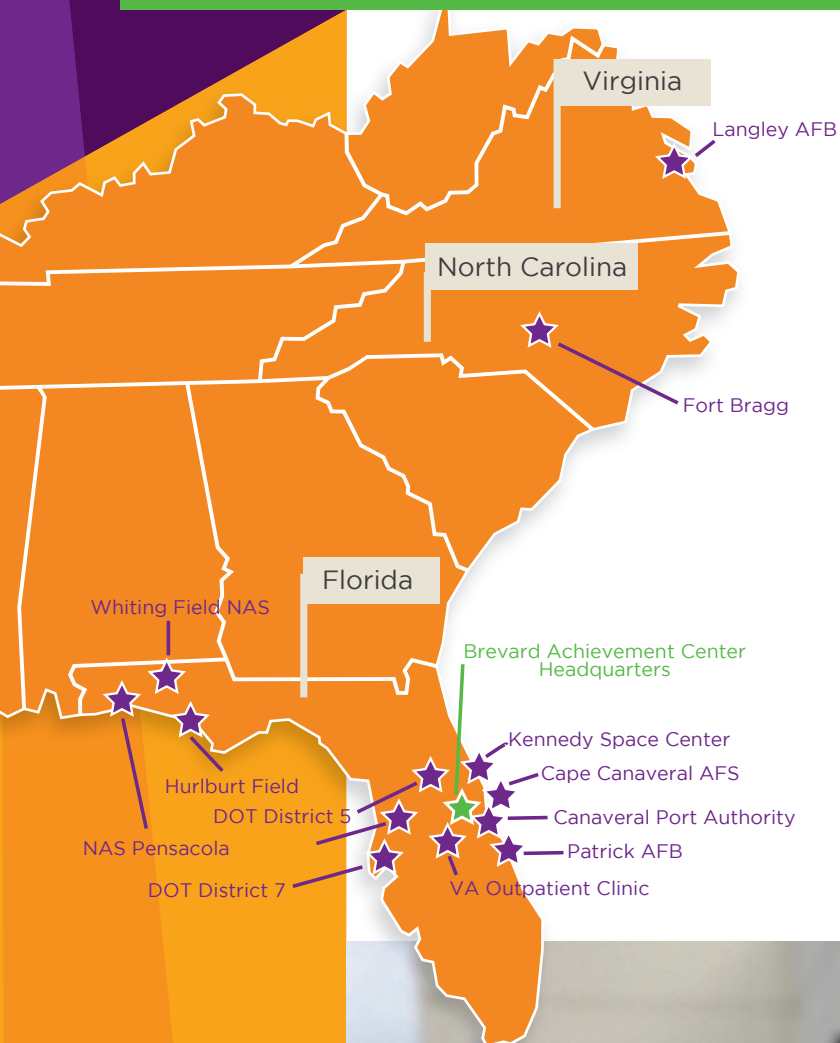

In his prior job, Orlando did not have health benefits or time off to be able to take care of himself physically or mentally, he also never felt like he was valued. Working for BAC has changed that for him both because of the benefits BAC offers and how BAC treats each person as an individual. Orlando has been able to get his previous health issues addressed and feels like a new person.

As one of the oldest team members working at Ft. Buchanan, Orlando is still one of the hardest workers. His career at BAC has helped him get on track to retire in a couple of years, something he would not have been able to do if he stayed with his last company.

Orlando feels that BAC “saved” him when he was hired on. He truly feels valued and sees his Ft. Buchanan coworkers as his family.

Success Stories

JAKON

Jakon participated in BAC's On the Job Training (OJT) program at Tijuana Flats as a floor greeter. During his training he learned how to greet customers as they arrive, run drink refills for guests and bus tables when guests are finished. He also makes a point to say goodbye to each guest as they leave and hold the door for them when possible. Jakon was doing such a good job that he was also taught how to clean high traffic areas such as the hot sauce bar, guests seating areas as well as the floors, windows and restrooms. His manager Angel has stated that he has received several customer compliments for being attentive to their needs and making sure they leave satisfied. Jakon was hired permanently after his OJT!



SHERRY

Sherry, one of the participants in our Adult Day Training program, recently did some self-advocacy that resulted in a special visit from Dr. Brenda Fettrow, City Manager for the City of Rockledge.

Sherry and her mom wrote to Dr. Fettrow asking that the city consider improvements to the sidewalk along Cogswell Street that would aid Sherry in being able to independently get to Barton Boulevard in her wheelchair from the BAC parking lot. During the visit, Dr. Fettrow shared how the city handles these types of requests and thanked Sherry for using her unique perspective to call attention to the project. Self-advocacy is one of the many life skills covered in our educational classes here at BAC and we were excited that Sherry's voice was heard. BAC now has a fully functional sidewalk and crosswalk!

Self-Advocacy at Work in DC

Team BAC was again selected as one of 50 SourceAmerica partners to participate in their Grassroots Advocacy Conference, in Washington.

This annual effort highlights the impact that public policy can have on employment for people with disabilities. This year's conference theme was "Power of Inclusion: Every Job. Every Story. Everyone." Tim, who works on our Kennedy Space Center contract, served as our self-advocate.

Tim has cerebral palsy and has worked hard to overcome the obstacles this challenge has created. His role in DC was to highlight how his job adds fulfillment to his life and those of his co-workers.

Self-advocates met with legislators on Capitol Hill to share personal stories and remind lawmakers that the work they do in Washington impacts the livelihood of their constituents, including people with disabilities, in their home districts. Each legislator was asked to support three key initiatives that would help provide additional employment opportunities for people with significant disabilities.

The highlight of the event and dream come true for Tim was meeting one of his personal heroes, Congressman Bill Posey.



Dream, Wish, and Wonder Program

The Dream, Wish, and Wonder program fulfills the mission of BAC by granting wishes to those in our community who may not otherwise experience things many take for granted. Terrence and Mike experienced a dream-come-true with a VIP tour of Kennedy Space Center, thanks to our friends at the KSC Visitor Complex.

"I was lucky enough to experience this with them, watching the day unfold with almost giddy eyes," said Amar Patel, BAC's CEO.

Mike and Terrance had a full day of exciting experiences at the Space Center including the Shuttle Launch Experience ride and visiting the Atlantis exhibit. We could really see how much they enjoyed the whole day!



CodeCraft Summer Camp

Seven local teens with disabilities all took part in a new camp at CodeCraft Works, a Melbourne educational technology company that trains students and educators in computer science.

The camp was a joint effort between CodeCraft Works and spearheaded by BAC.

Each student went through Google training, eventually passing the Google Power User course, which four of the students passed with a 100 percent score. Through the camp, utilizing their newly acquired Google Certifications, the teenagers were paired with local businesses to do paid analytics work on their websites.

Joshua McKenzie, who graduated from Melbourne Central Catholic this year, already had a grasp on CSS and HTML but was able to immerse himself in the JavaScript language and learn Google analytics through the camp.

“I feel like I’ve accomplished a whole lot this summer,” McKenzie said. “I plan on making a career out of computer sciences in the future.”

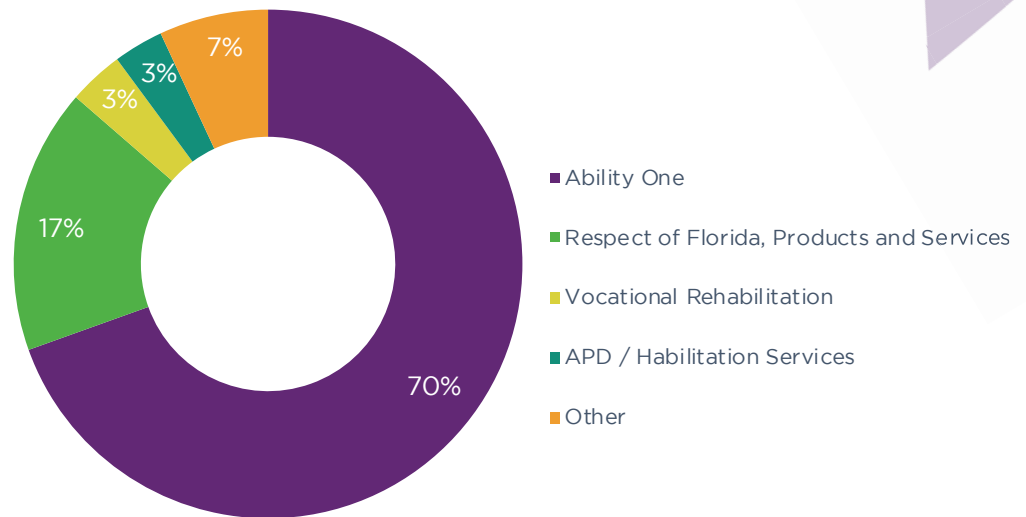

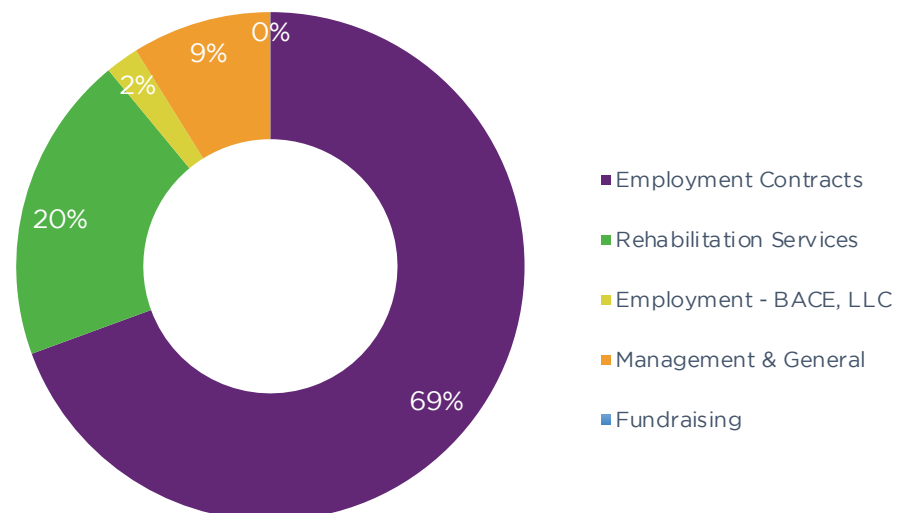

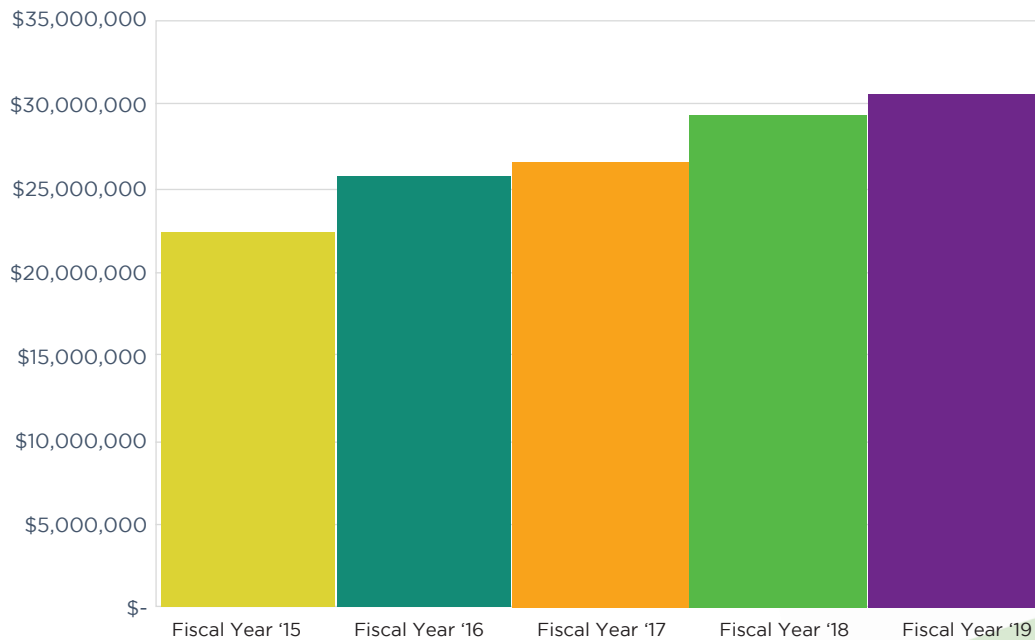

Second Annual E2A

We hosted our second annual E2A (Employ, Empower: Achieve) community awards, as part of National Disability Employment Awareness Month. The awards celebrate individuals and organizations across Brevard that have created opportunities for persons with disabilities to achieve success. Our 2018-19 honorees were:

USSSA - Employ, Empower Award

Recognizes organizations that create work opportunities in the community for people with disabilities.

Kennedy Space Center's DAAWG (Disability Awareness and Action Working Group) - Moving Forward Award (Pictured above)

Recognizes individuals and/or organizations that have made special efforts to assist people with disabilities in gaining new skills or improving access to employment opportunities.

Jennifer Cleveland - Believe and Achieve Award

Recognizes individuals with disabilities who have made significant personal strides in achieving success in work and/or life.

BAC Transportation

Reliable transportation continues to top the list of barriers to obtaining and maintaining employment by persons with disabilities. Although our Transportation Program is unable to serve all who need reliable rides, in its third year of operation service grew to 1,940 trips. This service is supported by a grant from the Department of Transportation. In addition, we received approval to become a Vocational Rehabilitation transportation provider for individuals who qualify.

Legislative Activities

We received support from the Florida Legislature for two key programs. Senator Tom Wright and Representative Tyler Sirois championed our request for funding for our Adults with Disabilities Program, providing enhanced life skills training. We also were recipients of a Culture Builds Florida grant, from the Department of State, Division of Cultural Affairs to support our Arts Program.
